Accomplishments as a Waterford Place HOA Board of Directors: During the past three years, I, along with my volunteer board colleagues, have always aimed to act in the best interests of the Waterford Place HOA community. We have demonstrated this by negotiating favorable terms, conditions, and pricing with contractors who provide operational and maintenance services for the HOA and Common Areas within the Waterford Place community. In addition, we have improved the process and functioning of the Board and AERC meetings. We have substantially improved the submission and review process and the response time for homeowners' Architectural and Environmental Change Requests (AECR).

Together, over the past three years, we have also worked to help maintain and increase the property values within our community by focusing on the repair and/or replacement of Common Area assets:

- Resurfacing the Waters Row Terrace roadway and parking areas,
- Replacing the decayed wood on the benches, table, and tree well in the picnic/sitting area
- Routinely cleaning the stormwater drains in the community
- Cleaning and painting the CBUs/community mailboxes
- Conducting a professional tree inventory and developing a tree care maintenance plan for the nearly 200 trees growing in the community's Common Areas; Removing dead and dying trees which were identified in the tree inventory
- Replacing and improving signage (no parking signs, fire lane signs, slow/5 mph signs, towing signs, slow/stop road stencils, etc.) throughout the community
- Installing a community message board near the picnic/sitting area to supplement communications with residents

The Waterford Place HOA's most recent capital projects include replacing and upgrading the playground equipment and installing underground drains to help improve the stormwater drainage concerns in the tot lot/playground area. Both projects are near completion, with the expected installation of the new playground equipment in mid-October-early November (due to supply-chain delays).

Closing Remarks: I think it is essential to be an effective board member by getting the HOA's business done on time, within budget, and in a transparent, professional, and compliant manner. As a member of the Waterford Place HOA Board of Directors, my goals are to continue promoting Waterford Place as a desirable residential community in Germantown, help maintain or increase the property values in our community, and maintain reasonable HOA assessment fees to care for the Common Areas.

I consider it a privilege to volunteer and work with my board colleagues, neighbors, and property management to achieve our HOA community's shared goals. I will continue to honor and respect others' viewpoints and approach each situation and resident with grace and dignity.
